When I got back to the office Tuesday night you weren't here. The phone was ringing and . . . 15 16 SFX: TELEPHONE RING, RING, RING, RING, ANSWER 17 18 19 SPADE: Sam Spade Detective Agency. 20 21 PATSY: (filtered) Mr. Spade, this is Patsy down at 22 Klondike Printing? 23 24 SPADE: Do ya have information for me on Al? 25



PATSY: (filtered) I've been trying to call you for 1 2 days. Granddad knew the fellow you were looking 3 for, but he wasn't going to talk about him. ..., well until Saturday when two men came to the shop. 4 They had a notebook that looked just like yours and 5 6 they started to push Granddad around. 7 8 SPADE: Is the old man all right? Did he call the 9 police? 10 PATSY: (filtered) Granddad's pretty rough himself and 11 12 he stood up to them. No police. Granddad doesn't 13 like the police. He said he can take care of 14 himself. When I asked him what they wanted, Granddad said that they wanted information about 15 16 Al. 17 SPADE: What did he tell them about Al? 18 19 PATSY: (filtered) Granddad said that Al was in the war 20 21 in Italy. They would talk about it some times. Al 22 wanted to get back to Italy. 23 They said Al was Dead. Is that right, Mr. Spade? 24 (UNCERTAIN) Why is he dead? 25 26 SPADE: Yes Patsy, He's dead. And I don't know why. I'll 27 stop by to see how the old man is doing. Bye now 28 Patsy. 29



SFX: PHONE HANG UP -and RING AGAIN and ANSWER 1 2 3 SPADE: Sam Spade Detective Agency 4 5 CLERK SUE: (filtered) Sam is that you? I've trying to 6 reach you for two days. 7 8 SPADE: (TIRED OF EXPLAINING) It was a long weekend Sue. 9 Do you have news on my boy? 10 11 CLERK SUE: (filtered) I've checked your name and I found Alfred Bondero. He was from San Francisco and 12 13 I even have an enlisted picture of him dated 1943. 14 He matches the description, and was assigned to Italy in Army Intelligence. 15 16 SPADE: (INTERRUPTS) You're the greatest! What do you 17 18 have for an address? 19 20 CLERK SUE: (filtered) No Address Sam. He is listed as 21 killed in action in Italy in 1943. No daughter. No 22 sybil, No next of kin. No benefits being paid. 23 24 SFX: STARTLED MUSIC UP AND UNDER 25 26 SPADE: (Narrative) I grabbed money from my desk (by the 27 way it was \$10 short -it'll come out of your next 28 paycheck) 29



EFFIE: Sorry Sam, we thought you were. .. 1 2 3 SPADE: (interrupting understandingly) Yes I know, you 4 thought I was dead. Anyway, I took the streetcar over to Sue's place. I got the photograph of three 5 6 young men in an army intelligence unit. It was a 7 qood photo. It was too qood. I placed my torn photo 8 right up against it. It was the same picture. My 9 man as the one on the left. Sue told me that 10 Bondero was the man in the middle. There was a 11 story to tell from that piece of paper. 12 MUSIC UP AND UNDER 13 14 SPADE: By 8 O'clock the next morning I was showing the 15 16 picture to the old man at the print shop. The man 17 on the left was definitely the man they knew as Al. 18 By 10 O'clock I was at the morque talking to Alice. 19 20 SFX: DISSOLVE -21 22 ALICE: We got confirmation of identity on the person we thought was Al Bondero. His real name was Steve 23 24 Hunter. He died from a blow on the head which 25 occurred at least 12 hours prior to death. You 26 know, we also found out that he's been listed as 27 AWOL from the military for 7 years. He must have 28 been living under a different name or something 29 like that.



1 2 SPADE: (slowly -thoughtfully) Yes, it was something 3 like that all right. Steve Hunter was in Bondero's 4 Unit. 5 ALICE: He's filed under "no surviving relatives ." 6 7 Do you know if he has anything of value? 8 9 SPADE: (Slowly) I'll have to get back to you on that. 10 There are a few questions I need to clear up. 11 12 MUSIC UP AND UNDER 13 SPADE: (Narrative) Well -I had more questions now that 14 15 when I started. Who was Bondero and who was Hunter, 16 and what did they have to do with the 30,000 Lira? 17 And who was trying to rough people up to find 18 Hunter, or Bondero, or whoever it was? I couldn't 19 help but come back to the picture of three men in 20 the army. 21 Bondero in the middle. Hunter on the Left. 22 Who was on the right? It was back to Sue's office at the Presidio. 23 24 25 SFX: CROSSFADE 26 27 SFX: STACKS OF PAPER RUSTLING -A PILE OF BOOKS BEING 28 DROPPED ON THE TABLE 29



CLERK SUE: These are all of the records we have here 1 2 Sam. Your guess is as good as mine. I can't figure 3 out how you're going to find the third man. 4 5 This area will be secured in less than an hour. 6 What do you want me to do. 7 8 SPADE: Can you look the other way? 9 10 CLERK SUE: Oh for you I guess I can. 11 12 SPADE: OK, Just lock the door and come and find me in 13 the morning. 14 SFX: DOOR CLOSE 15 16 MUSIC UP AND Through 17 18 19 ANNOUNCER: Reliving Radio is presenting the New 20 Adventures of Dashiell Hammett's Sam Spade. 21 22 COMMERCIAL: 23



SFX: HOLD UP APPLAUSE CARD 1 2 3 MUSIC UP AND THROUGH 4 5 ANNOUNCER: And now back to the Three's company caper. This weeks new adventure of Sam Spade. 6 7 8 SPADE: (narrative) Ten hours later I had found out that 9 Hunter, Bondero, and a guy named Sager were 10 assigned to counter-intelligence just about the 11 time that the picture was taken. Sager was court-12 martialed and got a dishonorable discharge in 1942. 13 Bondero was killed in action in Italy and Hunter, 14 according to the records went AWOL in Europe. No 15 one has seen him since. 16 17 I was on the way back to the print shop when I 18 stopped by my apartment. When we heard the fight we 12 called them. 13 SPADE: Oh, I see, there was a fight. 14 15 16 MABEL: They were making a lot of noise if they weren't 17 fighting. 18 SPADE: Well, I think I'll take a look. 19 20 21 SFX: CARPENTER SOUNDS OUT 22 23 SPADE: (narrative) I didn't ask any more questions. I 24 looked into my room and it was quite a mess. I 25 didn't understand the blood until I saw my filing cabinet. 26 27



EFFIE: (Forlorn) Sam! They got the Italian bankbooks. 1 2 Isn't that what they were looking for? Oh Sam they 3 got everything.
